## Individually calculated optional medical acts and services

- o **Medical acts and services** performed by all the employed and authorized doctors of the Hospital, whereas these physicians are engaged in the treatment, if these doctors are entitled to special calculation of their acts and services within comprehensive or partial hospitalisation, as well as within the treatment provided to a patient prior the hospitalisation and after the hospitalisation (§ 115a of the Social Act, Part V), including the acts and services from such doctors whose medical acts and services were initiated by these doctors or health-care institutions beyond the Hospital. This shall be applicable also in the event, when optional medical acts and services are calculated by the Hospital; payment settlement shall follow the GOÄ/GOZ Fee Schedule, as amended. This Medical Fee Schedule is available, upon request, in our Patients Billing Department.

**In case of any unexpected obstacles on the side of any optional doctor of respective specialized department, I do agree his/her permanent medical representative is allowed to take over his/her tasks for the purposes of the present Agreement.**

- o Accommodation in a **single room with toilet and shower**

- o Accommodation in a **double room with toilet and shower**

**Klinikum Weiden** Price per one calculated day 54,30 €

- o I wish for the period not exceeding four days to book a single or double room, which I have chosen, for case I will not be able to use the room temporarily (e.g. when staying in hospital delivery room or intensive care unit). The period for which is the room booked, however not used anyhow, the Hospital shall charge the rate lowered by 25 %.

Description of services related to single and double rooms is available in DRG Payment Tariff Schedule.

#### Accommodation and boarding for one accompanying person

- o Full board with staying overnight 45.00 € payment for one calculated day
- o Full board without staying overnight 16.50 € payment for one calculated day
- o Overnight 28.50 € payment for one calculated day
- o Breakfast 4.50 € payment for one calculated day
- o Lunch 7.50 € payment for one calculated day
- o Dinner 4.50 € payment for one calculated day
- o Family room with full board (maternity ward) 70.00 € payment for one calculated day

#### Notice:

- Agreement on optional medical acts and services shall be applicable to the entire case of treatment, in spite of the fact when such a treatment has been interrupted.
- Optional and individually calculated medical acts and services agreed between the Hospital and the Patient shall be performed upon personal and factual possibilities of the Hospital, provided that any Hospital general acts and services would not be therefore affected.
- In case of birth giving the provision of optional medical acts and services is not applicable to a new-born. For a new-born shall be applicable special agreement on optional medical acts and services.
- The Hospital may refuse to enter into the agreement on optional medical acts and services with such patients who did not settle the payment for previous in-hospital treatment or the payment was delayed.
- The Hospital may immediately interrupt the provision of optional medical acts and services, if this is necessary due to the provision of medical care towards other patients; in other cases the agreement with the patient may be terminated anytime, which becomes effective by the end of the following day; due to serious reasons the agreement may be terminated by both the Parties, whereas the term is not adhered to.
- The Patient is obliged, within the departments which are used by external doctors, to conclude required agreements on medical acts and services provided to them by external doctors, doctors-consultants or external health-care institutions – in spite of the fact when the optional acts and services were agreed with the Hospital, such agreements shall be entered into not with the Hospital, but directly with external doctor or doctor-consultant or external health-care institution.
- If the optional medical acts and services were agreed, then the Hospital may charge reasonable advance payments, as well as partial payments.
- Within the use of optional medical acts and services the choice is not limited only to individual in-hospital doctors who are entitled to perform the actions (§ 17, paragraph 3 of the Act on in-hospital payments). The Agreement on optional medical acts and services shall be applicable to all the doctors employed or engaged with the Hospital, i.e. those who participate in the treatment, if they are entitled to special calculation of their acts and services within the entire or partial hospitalisation, as well as in the course of treatment prior and after the hospitalisation (§ 115a of the Social Act, Part V), including all the acts and services from such doctors whose medical acts and services that were initiated by these doctors or health-care institutions beyond the Hospital. This shall be applicable also in the event, when optional medical acts and services are calculated by the Hospital.
- Individually calculated medical acts and performances, if these are calculated by the Hospital, optional doctor of specialized department or health-care institution directly or when supervised by optional doctor pursuant to the professional instruction from senior doctor of the department or institution (§ 4, paragraph 2, first sentence of the GOÄ/GOZ Medical Fee Schedule) or these are provided to the patient by any permanent medical representative (§ 4, paragraph 2, third sentence of the GOÄ/GOZ Medical Fee Schedule).

#### Notice:

The use of the above stated optional medical acts and services is not subject to any statutory health insurance. When sourcing the optional medical acts and services the Patient shall be understood as individual payer and is obliged to pay the remuneration. Please, check and be sure, your private health insurance / healthcare contribution or your statutory health insurance will cover these costs from extraordinary optional tariff according to Section 53 of the Social Act V.
